Charles Bellinger is an Associate Professor of Theology and Ethics at Brite Divinity School of Texas Christian University. He is the author of The Genealogy of Violence (Oxford, 2001), The Trinitarian Self (Pickwick, 2008), The Joker Is Satan, and So Are We (Churchyard Books, 2010), and Jesus v. Abortion (Cascade, 2016).

Karen C. Chan currently serves as Academic Dean and Associate Professor of Philosophy at St. Patrick's Seminary & University of the Archdiocese of San Francisco. She received her undergraduate degrees from the University of San Francisco and her doctorate in Philosophy from the University of Notre Dame. Her research interests center on Aristotelian-Thomistic moral philosophy and its application to contemporary issues such as medical ethics and motherhood.

John J. Conley, S.J. holds the Henry J. Knott Chair in Philosophy and Theology at Loyola University Maryland. Jason T. Eberl is the Semler Endowed Chair for Medical Ethics in the College of Osteopathic Medicine at Marian University (Indianapolis IN). He earned his Ph.D. in Philosophy at Saint Louis University. From 2003 to 2013 he held a tenure-line appointment in the Department of Philosophy in the Indiana University School of Liberal Arts. In addition to authoring many articles, he has published a monograph entitled Thomistic Principles and Bioethics. Dr. Eberl's research interests focus on medical ethics, metaphysics, and medieval philosophy. He is particularly interested in the thought of Thomas Aquinas and how his theories of human nature and morality may inform the ethical evaluation of various issues in medical ethics, including those at the margins of human life – such as abortion, human embryonic stem cell research, the

definition of death, euthanasia, and organ donation — as well as emerging issues in genetics — such as reproductive cloning, genetic enhancement, and the creation of human/non-human chimeras — and justice in the allocation of health care resources.

Andrew M. Essig is a Professor of Political Science at DeSales University, Center Valley PA. He received his Ph.D. in Political Science from Penn State University, University Park, PA. He studied 1994-1996 at the Christian-Albrechts-Universität in Kiel, Germany through the DAAD. He has several published various articles, including "John Paul II and the New International Order" Catholic Social Science Review, "Catholic International Relations Theory" Fellowship of Catholic Scholars Quarterly, and "The World Bank," C-FAM, among others. His current areas of interest include: U.S.-Holy See diplomatic relations and Catholic International Relations Theory. He teaches numerous courses in international relations, along with introductory courses in American Government and Political Philosophy.

Vicki Evans is Respect Life Director for the San Francisco Archdiocesan Office of Public Policy and Social Concerns. Her responsibilities include directing community activities, educational programs and legislative advocacy in diverse pro-life areas including abortion, stem cell research, euthanasia and bioethics. William L. Saunders, Jr. writes and speaks on a wide-range of life-related and human rights topics. In addition to long years of service at Americans United for Life, he was Senior Fellow in Bioethics and Human Rights Counsel at the Family Research Council. A member of the Supreme Court bar, he has authored numerous legal briefs in state, federal, foreign, and international courts.
