*Charles Bellinger* is an Associate Professor of Theology and Ethics at Brite Divinity School / Texas Christian University. He is the author of *The Genealogy of Violence* (Oxford, 2001), *The Trinitarian Self* (Pickwick, 2008), *The Joker Is Satan, and So Are We* (Churchyard Books, 2010), and *Jesus v. Abortion* (Cascade, 2016).
